Whereas, no activity having bearing on environment can be set up or put in operation, without the prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, Poultry farm (**Chick Rearing**) of large category is classified in **Red category**, for the purposes of obtaining of consent from the JK PCC, keeping in view the pollution potential of the unit

Whereas, a large **Poultry Farm (Chick Rearing)** has been set up and put in operation by Animal Husbandry Department at Khati Darwaza Rainawari-Srinagar without consent of the J&K PCC, and adequate pollution control devices /measures. besides established in the residential area.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated **16-04-2022**, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.

Whereas pressing complaints from local residents have been received against the illegal operation of said Poultry Farm in question which stand verified as genuine.

Whereas, the unit holder has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection.


Whereas, Regional Director, Pollution Control Committee, Kashmir vide his letter PCC/ROK/LS/22/251-52 dated 27-12-2022 has recommended closure of the Poultry Farm.

Whereas, the unit in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under Section 33 (A) and Section 31 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively and Section 5 of the Environment (Protection) Act, 1986 immediate closure of poultry farm set up and put in operation by Department of Animal Husbandry **at Khati Darwaza Rainawari-Srinagar** is hereby ordered and in this behalf the:-

- Deputy Commissioner/ District Magistrate, **Srinagar** is directed to get the poultry farm set up and put in operation by Department of Animal Husbandry **at Khati Darwaza Rainawari-Srinagar** closed immediately.
- Executive Engineer, KPDCL, Electric Division Srinagar is directed to disconnect the electric supply to the above said Poultry Farm immediately.
- Director, Industries & Commerce Department, **Kashmir** is directed to deregister the unit, if registered.
- Manager, **Poultry Farm (Chick Rearing) at Khati Darwaza Rainawari-Srinagar** is directed to cease the operation of the Poultry Farm forthwith.
