ORDER No.: /16-JKPCC of 2024
DATED 28-06-2024

Whereas, closure of **M/s Khajuria Service Station, Ward No. 11, Shiv Nagar, Near SSP Office, Udhampur** was ordered by the JKPCCC vide order No. **328 JKPCCC of 2024** dated **22-02-2024** for the failure of the proprietor of Service Station to obtain mandatory consent of the JKPCCC and also for operating the service station without having requisite Effluent Treatment Plant (ETP) ; and

Whereas, the above said order has been implemented by the District Administration, Udhampur and the Service Station is presently closed and sealed; and

Whereas, the unit holder represented against the closure order before the Divisional Officer, PCC, Udhampur on 27-04-2024 requesting therein that they had complied with the directions passed w.r.t installation of necessary Pollution Control Devices in the service station and requested for re-opening of their service stations; and


Whereas, pursuant to this, the Divisional Officer, JKPCCC, Udhampur after conducting inspection submitted a report to the Regional Director, PCC, Jammu vide his no. PCC/Udh/DO/2024/31 dated 29-04-2024 stating therein that the unit holder has installed a settling tank, but the premises is at present closed. The Regional Director, PCC, Jammu, while forwarding the report of DO, PCC, Udhampur to this office observed that the measure adopted seems to be inadequate; and

Whereas, the unit holder has again represented to the J&K PCC on 24-06-2024 with the request that he has complied with the PCM norms and taken required Pollution Control Measures with further request to allow him to operate the service station on trial basis for checking the efficacy of PCDs .

Now, therefore, in view of the aforesaid reasons and request made by the unit holder, the Order No. **328 JKPCCC of 2024** dated **22-02-2024** is hereby kept in abeyance for a period of one month purely for monitoring the efficiency of PCMs/PCDs and waste water quality generated from the service station, which shall be followed by inspection and sampling & testing of waste water generated from the service station by the team of officers comprising of a Scientist and Environmental Engineer.

This Order shall remain valid only for a period of one month from the date of issuance.
