Whereas closure of **Band Saw Mill of Sh. Bashir Ahmad Lone, Takiya Wagam Pulwama** was ordered by the Board vide Order No. **193 SPCB of 2013 dated 30-08-2013**, on the basis of complaints received from neighbors and for the failure of the unit holder to obtain consent from the JK SPCB.

Whereas, the unit holder and the complainant filed separate litigations before the Hon'ble High Court and the Hon'ble High Court by virtue of common order dated 20-05-2022 had disposed these writ petitions with the direction to respondents to consider the renewal of license of the unit in accordance to J&K Wood Based Industry (Registration and Regulation) Rules 2012, besides providing an equal opportunity of being heard to the petitioners.

Whereas, in compliance to the order dated 20.05.2022, both the contesting parties were heard in person by the Regional Director (Kashmir).

Whereas, Regional Director JK PCC (K) vide his letter dated PCC/ROK/LS/2023/386- 89 dated 06-06-2023 has recommended for keeping the closure order in abeyance for a period 15 days to facilitate monitoring of noise pollution to enable the JK PCC to take a final call in the matter.

Now therefore, closure order No. **193 SPCB of 2013 dated 30-08-2013** issued against **Band Saw Mill of Sh. Bashir Ahmad Lone, Takiya Wagam Pulwama** is hereby kept in abeyance for 15 days to facilitate monitoring of noise pollution and to enable the Board/Committee to take further necessary action in the matter on merits of the noise monitoring.
