ORDER NO. : 119 JK PCC of 2023
DATED : 16/10/2023

Whereas closure of M/s S.S. Industries, Shanker Colony Gangyal Jammu was ordered by the J&K Pollution Control Board vide Order No. 24 JK PCB of 2019 dated 15-05-2019, for illegal manufacturing of Polythene Carry Bags and allied products of less than 50 microns which was banned in the state of Jammu and Kashmir in terms of SRO-45 dt. 03-02-2017.

Whereas, unit holder challenged the closure order before the Hon'ble High Court of Jammu and Kashmir in WPC No. 1013/2020 titled M/s S. S. Industries Versus Union Territory of J&K & Ors and again filed a review writ petition in WPC No. 162/2021 titled M/s S.S. Industries Versus UT of J&K & Ors wherein Hon'ble High court in its order dt. 29-10-2022 dismissed the writ petition with cost of Rs. 20,000/- against the petitioner to be paid within a period of one month.

Whereas, after depositing the amount fined by the Hon'ble High court, the unit holder represented to the JK Pollution Control Committee seeking revocation of closure order and also undertaken that he will only manufacture paper Napkin, Paper Plates, Paper Cups etc. after obtaining consent from the Pollution Control Committee.

Whereas, Regional Director, PCC Jammu vide letter No. PCC/RDJ/G/Legal/1583 dt. 14-08-2023 recommended the case for keeping the closure order in abeyance enabling the unit holder to delete the manufacturing of HM/LD Polythene Bags (above 50 microns) from the DIC Registration.

Now, therefore, the closure order No. 24 JK PCB of 2019 dated 15-05-2019 issued against M/s S.S. Industries, Shanker Colony Gangyal Jammu is hereby kept in abeyance for 15 days enabling the unit holder to dismantle the banned polythene/Sup manufacturing instruments/equipments from the unit and to facilitate deleting the manufacturing of HM/LD Polythene Bags (above 50 Microns) from the DIC Registration issued vide No. DIC-J/14214-Prov/1171-72 dt. 11-05-2018 registered provisionally vide EM No. 07/004/11/14214(Part-I) dt. 12-01-2018 and shall not put the unit in operation for other items without obtaining valid consent from the J&K Pollution Control Committee.
