**Subject: Closure of M/s Minor Mineral (River Bed Material), Block- 29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri.**

**Order No. : 169 JK PCC of 2024**  
**Dated : 19 /09 /2024**

Whereas, on the basis of pollution potential, Mining of minor mineral is classified as **Orange category** and obtaining the consent from the Pollution Control Committee is mandatory alongwith adoption of pollution control mechanism to achieve the Prescribed Standards of pollution; and

Whereas, Consent to Operate (renew) was granted to **M/s Minor Mineral (River Bed Material), Block- 29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri**, vide No. **PCC / digital / 22062941742 of 2022** dated **08-07-2022** valid upto**March,2024**, with specific terms and conditions for **17214 MT/Annum**, as per the quantity mentioned in Environmental clearance obtained by the stakeholder vide No. **JKEIAA/2021/442/657-70** dated **26-03-2021**, but thereafter, failed to get the consent renewed from the J&K Pollution Control Committee as warranted under Section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981;and

Whereas, Hon'ble National Green Tribunal Principal Bench, New Delhi in O.A. No. 360/2015 titled National Green Tribunal Bar Association Versus Virender Singh in its order dt. 26-02-2021 have directed to take action against the stakeholders found involved in illegal mining of minor mineral; and

Whereas, Minor Mineral **Block-29** operated by Shri Rahil Choudhary under the name and style of M/s Minor Mineral( River Bed Material) **Block- 29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri** is currently operational in violation of Section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 , without valid consent from the J&K Pollution Control Committee; and


Whereas, M/s Minor Mineral (River Bed Material), **Block- 29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri** cannot be permitted to operate without consent from the J&K Pollution Control Committee.

Now therefore, in exercise of powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued: -

- i. Deputy Commissioner/ District Magistrate, **Rajouri** is directed to cease the operation of the Minor Mineral **Block-29** of Shri Rahil Choudhary under the name and style of **M/s Minor Mineral (River Bed Material) Block- 29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri** , immediately.
- ii. Director, Department of Geology & Mining is directed to cease the operation of the Minor Mineral **Block-29** operated by Shri Rahil Choudhary immediately.
- iii. **Mr. Rahil Choudhary**, stake holder of **M/s Minor Mineral (River Bed Material) Block-29, Dhaleriwali Nadi Upstream Khawas Bridge, Village Khawas-District Rajouri**, is directed to cease the operation of the minor Mineral Block-1/2 immediately.
