Sub:- Closure of Butcher House (Slaughter House) of Mohd Sadiq Khan Butcher House at Challgund Hyhama, District Kupwara.

Order No: 175 PCC of 2024

Dated: 04/10/2024

Whereas, no activity having bearing on environment can be set up or put into operation, without the prior consent of the J&K Pollution Control Committee, as warranted under Section 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 respectively; and

Whereas, **Butcher House (Slaughter House)** is classified as **Orange category**, for the purposes of obtaining consent from the J&K Pollution Control Committee, keeping in view the pollution potential of the unit; and

Whereas, **Butcher House of Sh Mohd Sadiq Khan located at Challgund Hyhama, District Kupwara**, has been established and put into operation unauthorizably without from consent of the J&K Pollution Control Committee, in flagrant violation of the above stated laws that too without adequate pollution control devices/ measurers; and

Whereas, the unit holder was accordingly served with repeated notices, calling upon him thereunder to show reasons as to why legal action including closure of his unit be not taken and but he failed to show any tenable response, besides, also did not took measures to meet the requirements of laws governing environmental protection; and


Whereas, the unit in question cannot be allowed to operate un-authorizedly with above status to the detriment of human health and environment necessitating for immediate action especially the closure of the unit; and

Now therefore, in view of the above and in exercise of powers vested to the J & K Pollution Control Committee under **Section 33 (A) of the Water (Prevention & Control of Pollution) Act 1974 and Section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981 read with Section 5 of Environment (Protection) Act, 1986**, following directions are hereby issued: -

- i). The Deputy Commissioner/ District Magistrate, **Kupwara** is directed to close down the **Butcher House established by Mr. Mohd Sadiq Khan at Challgund Hyhama, Kupwara**, immediately.
- ii). Executive Engineer, PHE Division, Kupwara is directed to disconnect the water supply to the unit immediately.
- iii). Executive Engineer, KPDCL Kupwara is directed to disconnect the electric supply to the unit immediately.
- iv). Mr. Mohd Sadiq Khan, Prop. **Butcher House at Challgund Hyhama, Kupwara** is directed to cease the operation of the Butcher house forthwith.
