Whereas, no activity having bearing on environment can be taken in hand, without prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, the Fabrication unit is classified in **Orange** category on the basis of its pollution potential, for the purposes obtaining of consent from the Board.

Whereas, a **Fabrication unit**, has been setup and put in operation by Sh. Arshad Ahmad Wagay at Krangsoo Anantnag in violation of above stated laws that too bereft of adequate pollution control devices/ measures.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 24-12-2022, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.

Whereas, the unit holder has failed to show any response to the notices, besides failing to take measures to meet the requirements of laws governing environmental protection.

Whereas, Regional Director, JK PCC Kashmir vide his letter No PCC/ROK/LS/023/14-15 dt 01-02-2023 has recommended closure of above said unit

Whereas, the unit in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under **Section 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5 of Environment (Protection) Act, 1986**, immediate closure of **M/s Fabrication Unit, of Sh Arshad Ahmad Wagay at Krangsoo-Anantnag**, is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, **Anantnag** is directed to get **M/s Fabrication Unit, of Arshad Ahmad Wagay at Krangsoo**, closed immediately.
- ii). Exe. Engineer (KPDCL) **Anantnag** is directed to snap the electric supply to the above said unit immediately.
- iii). Director Industries & Commerce, **Kashmir** is directed for deregistering the above said unit.
- iv). Sh. Arshad Ahmad Wagay Proprietor **M/s Fabrication Unit, Krangsoo Anantnag**, is directed to cease the operation of unit forthwith.
