Whereas closure of **Composite Unit** comprising **Spice Grinding, Atta Chaki and Rice Husking unit of Sh. Mohammad Sabir Rather, Tarathpora, Amargarh-Kupwara** was ordered by the Board vide Order No. **72 JK PCC of 2022 dated 12-09-2022**, on the basis of complaints received from neighbors and for the failure of the unit holder to obtain consent from the JK PCC.

Whereas, the unit holder represented against the closure order vide his representation dt 28-11-2022, seeking its withdrawal on the basis of having taken adequate measures to control noise pollution from the unit.

Whereas, Regional Director JK PCC (K) vide his letter dated PCC/ROK/LS/2022/126 dated 23-01-2023 has recommended keeping the closure order in abeyance for 30 days to facilitate monitoring of noise pollution to enable the JKPCCC to judge efficiency of measures taken by the unit holder to control the noise pollution.

Whereas, aforementioned closure order was kept in abeyance for 15 days vide Order No. 29-JKPCCC of 2023 dated 11-02-2023 so as to monitor the noise level of the unit.

Whereas, Regional Director, JK PCC vide his communication No. PCC/ROK/LS/23/733-35 dated 19-10-2023 has forwarded the noise monitoring report of the unit, which is within permissible limits.

Now therefore closure order No. **72 JK PCC of 2022 dated 12-09-2022 issued against Spice Grinding, Atta Chaki and Rice Husking unit of Sh. Mohammad Sabir Rather, Tarathpora, Amargarh-Kupwara** is hereby withdrawn forthwith to facilitate process the consent case of applicant.
