Whereas, no activity having bearing on environment can be set up or put in operation, without the prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, Utensil Manufacturing is classified in **Green category**, for the purposes of obtaining of consent from the Committee, keeping in view the pollution potential of the unit

Whereas, Mr. Ghulam Nabi Mir has set up and put in operation a copper manufacturing utensils unit under the name and style of M/s Mir Copper Utensils, Rather Mohalla, Aanchar Soura-Srinagar has failed to obtain up to date consent of the JK PCC as such is currently in operation in flagrant violation of the above stated laws viz consent of the J&K PCC, without adequate pollution control devices/ measures and that too at an objectionable site.

Whereas pressing complaints from local residents have been received against the operation of unit in question which stands verified as genuine.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 25-07-2022, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.

Whereas, the unit holder has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection

Whereas, Regional Director, Pollution Control Committee, Kashmir vide his letter No. PCC/ROK/LS/2022/251-52 dated 27-12-2022 has recommended closure of the unit.

Whereas, the units in question cannot be allowed to run un-authorisedly with above status and to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under Section 33 (A) and Section 31 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively read with Section 5 of the Environment (Protection) Act, 1986 immediate closure of copper manufacturing utensils unit of Mr. Ghulam Nabi Mir under the name and style of M/s Mir Copper Utensils, Rather Mohalla, Aanchar Soura-Srinagar is hereby ordered and in this behalf the:-

i). Deputy Commissioner/ District Magistrate, Srinagar is directed to get the copper manufacturing utensils unit of Mr. Fayaz Ahmad Beigh under the name and style of M/s Mir Copper Utensils, Rather Mohalla, Aanchar Soura-Srinagar closed immediately.

ii) Executive Engineer, KPDCL, Electric Division, Srinagar is directed to snap the electric supply to the above said unit immediately.

iii). Director, Industries & Commerce Department, Kashmir is directed to deregister the unit, if registered.

iv). Mr GH Nabi Mir Prop. M/s Mir Copper Utensils, Rather Mohalla, Aanchar Soura-Srinagar is directed to cease the operation of the unit forthwith.
