Whereas, no activity having bearing on environment can be taken in hand, without prior Consent of the Pollution Control Committee, as warranted under **Section 25/26** and **Section 21** of the **Water (Prevention and Control of Pollution) Act 1974** and **Air (Prevention and Control of Pollution) Act, 1981** respectively.

Whereas, Mr. Tariq Ahmad Bhat has set up and put in operation a Restaurant under the name and style of **M/S Amigo's Food & Hospitalities, Hazratbal, Opp. Kashmir University Srinagar** is operational in flagrant violation of above said requirements of law as he has failed to obtain mandatory consent from the JK PCC.

Whereas, a complaint has been received against the operation of the above said Restaurant which has been verified on ground as genuine.

Whereas, the owner of the Restaurant was accordingly served with repeated notices, particularly notice dated **09-10-2023**, calling upon him there under to show reasons as to why legal action including closure of his Restaurant be not taken.

Whereas, fresh inspection of the Restaurant was carried out by the Divisional Officer, PCC Srinagar on **01-09-2023**, reported that the status of the Restaurant remains unchanged and accordingly Regional Director, Pollution Control committee Kashmir vide letter No. **PCC/ROL/LS/23/19-20 dt. 25-11-2023** recommended the case for closure order.

Now therefore in exercise of powers vested in the J & K Pollution Control Committee under **Section 33(A)** of the **Water (Prevention & Control of Pollution) Act 1974** and **Section 31(A)** of the **Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5** of Environment (**Protection**) **Act, 1986**, immediate closure of Restaurant of Mr. Tariq Ahmad Bhat under the name and style of **M/S Amigo's Food & Hospitalities, Hazratbal, Opp. Kashmir University Srinagar** is hereby ordered and in this behalf the:-

- Deputy Commissioner/ District Magistrate, **Srinagar** is directed to close down the Restaurant of Mr. Tariq Ahmad Bhat under the name and style of **M/S Amigo's Food & Hospitalities, Hazratbal, Opp. Kashmir University Srinagar**.
- Executive Engineer (KPDCL), Electric Division Hazratbal Srinagar is directed to disconnect the electric supply to **M/S Amigo's Food & Hospitalities, Hazratbal, Opp. Kashmir University Srinagar**
- Director Tourism **Kashmir** is directed to deregister the Restaurant, if registered.
- Mr. Tariq Ahmad Bhat Prop. **M/s Amigo's Food & Hospitalities, Hazratbal, Opp. Kashmir University Srinagar** is directed to cease the commercial operation of the Restaurant forthwith.
