ORDER NO.: 204 JK PCC of 2024

Whereas closure of **M/s Manoj Guest House, Main Bazar Katra-District Reasi** was ordered by the JK Pollution Control Committee vide Order No.67 JK PCC of 2023 dt. 21-09-2023, for failure of hotelier to obtain consent from the JK PCC and to have the facility of Soakage pit and Septic Tank in place in the Hotel.

Whereas, on latest inspection carried out by the Divisional Officer, Control Committee, Reasi on 25-10-2023, reported that the owner of the Hotel/Guest House has constructed the septic Tank and Soakage pit and put the same in operation, besides also stated that the owner of the Guest House has applied for Consent to Operate (Fresh) from the JKPCCC .

Whereas, Regional Director, Pollution Control Committee, Jammu vide letter No. PCC/RDJ/O/23/2722-23 dt. 23-11-2023 confirms the report of the Divisional Officer, Pollution Control Committee Reasi and accordingly recommended withdrawal of the closure order against **M/s Manoj Guest House, Main Bazar Katra-District Reasi**.

Now, therefore, closure order No. 67 JK PCC of 2023 dt. 21-09-2023, issued against **M/s Manoj Guest House, Main Bazar Katra-District Reasi** is hereby withdrawn, subject to the condition that the hotelier will not put the hotel in operation without obtaining the consent from the JKPCCC.
