Whereas closure of M/s **Hotel Shraddha, New Bus Stand Katra-District Reasi** was ordered by the JK Pollution Control Committee vide Order No.62 JK PCC of 2023 dt.18-09-2023, for failure of the unit hotelier to obtain consent of the JK PCC and to have Sewage Treatment Plant (STP) of requisite capacity in place in the hotel.

Whereas, on latest inspection carried out by the Divisional Officer, Control Committee, Reasi on 19-10-2023, reported that the hotelier has installed Sewage Treatment Plant (STP) of 20 KLD capacity, besides also reported that the hotelier has applied for Consent to Operate (Fresh) from the JK Pollution Control Committee.

Whereas, Regional Director, Pollution Control Committee, Jammu vide letter No. PCC/RDJ/O/23/2677-78 dt. 21-11-2023 confirms the report of the Divisional Officer, Pollution Control Committee Reasi and accordingly recommended withdrawal of the closure order against M/s **Hotel Shraddha, New Bus Stand Katra-District Reasi**

Now, therefore, closure order No. 62 JK PCC of 2023 dt.18-09-2023 issued against M/s **Hotel Hotel Shraddha, New Bus Stand Katra-District Reasi** is hereby withdrawn, subject to the condition that the hotelier will not put the hotel in operation without obtaining the consent from the JKPCC.
