Whereas, Consent to Operate (R) issued to **M/s Mir Rather Hollow Block unit at Kadlebal Pampore Pulwama** vide consent No. **SPCB/digital/23063357592 of 2023 dt.16-02-2023**, valid upto **January,2025** with some terms and conditions.

Whereas, a complaint has been received from locals against the operation of the unit for causing Noise pollution which has been verified on ground as genuine.

Whereas, unit holder was accordingly served with notice vide No. **PCC/ROK/LS/2023/1068-71 dt. 04-04-2023** to show cause within 7 days failing which legal action under environmental laws shall be taken against the unit, which the unit holder has responded to the notice on 10-04-2023 devoid of any merit.

Whereas, noise monitoring was conducted by the Divisional Officer, Pollution Control Committee, Pulwama which reveal that the noise level does not confirm the permissible limit as prescribed for residential area under the Noise (Regulation and Control) Rules, 2000 and recommended the case for closure order.

Whereas, Regional Director, Pollution Control Committee, Kashmir vide letter No. **PCC/ROK/LS/2023/72-74 dt. 31-08-2023** confirm the report of the Divisional Officer, Pollution Control Committee Pulwama and accordingly recommended for closure order.

Now, therefore, Consent to Operate (R) issued to **M/s Mir Rather Hollow Block unit at Kadlebal Pampore Pulwama** vide consent No. **SPCB/digital/23063357592 of 2023 dt.16-02-2023**, valid upto **January,2025** is hereby withdrawn forthwith and in exercise of powers vested in the J & K Pollution Control Committee under **Section 33 (A)** of the **Water (Prevention and Control of Pollution) Act,1974** and **Section 31 (A)** of the **Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5** of the **Environment (Protection) Act, 1986**, immediate closure of Hallow Block unit under the name and style of **M/s Mir Rather Hollow Block unit at Kadlebal Pampore Pulwama**, is hereby ordered and in this behalf the:-

- Deputy Commissioner/ District Magistrate, Pulwama is directed to get the Hallow Block unit under the name and style of **M/s Mir Rather Hollow Block unit at Kadlebal Pampore Pulwama** closed immediately.
- Executive Engineer, (KPDCL), Electric Division, Pulwama is directed to disconnect the electric supply to the above said unit immediately.
- Director, Industries & Commerce Department, Kashmir is directed to deregister the unit, if registered.
- Mr. Showkat Ahmad Rather, Prop. **M/s Mir Rather Hollow Block unit at Kadlebal Pampore-District Pulwama** is directed to cease the operation of the unit forthwith.
