Whereas, **Brick Kiln** is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK PCC.


Whereas, **M/s Bismillah Brick Kiln , Harda Batapora, Budgam** has been set up and put it in operation in violation of above stated laws without Consent of the JK Pollution Control Committee that too bereft of adequate pollution control devices/ measures.

Whereas, the Brick Kiln in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under **Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974** and **Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5 of Environment (Protection) Act, 1986** immediate closure of the Brick Kiln under the name and style of **M/s Bismillah Brick Kiln , Harda Batapora, Budgam** is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, **Budgam** is directed to get the Brick Kiln under the name and style of **M/s Bismillah Brick Kiln , Harda Batapora, Budgam** , closed immediately.
- ii). Director Industries & Commerce, Kashmir for deregistering the unit, if registered.
- iii). Prop. **M/s Bismillah Brick Kiln , Harda Batapora, Budgam** is directed to cease the operation of the Brick Kiln forthwith.
