Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee, warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, **Brick Kiln** is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK PCC.

Whereas, **M/s Baba Hyder Brick Kiln, Hushroo-Chadoora, Budgam** has been set up and put it in operation in violation of above stated laws without consent of the JK Pollution Control Committee that too bereft of adequate pollution control devices/ measures.

Whereas, the Brick Kiln in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under **Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974** and **Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5 of Environment (Protection) Act, 1986** immediate closure of the Brick Kiln under the name and style of **M/s Baba Hyder Brick Kiln, Hushroo-Chadoora, Budgam** is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, **Budgam** is directed to get the Brick Kiln under the name and style of **M/s Baba Hyder Brick Kiln, Hushroo-Chadoora, Budgam**, closed immediately.
- ii). Director Industries & Commerce, Kashmir for deregistering the unit, if registered.
- iii). Prop. **M/s Baba Hyder Brick Kiln, Hushroo-Chadoora, Budgam** is directed to cease the operation of the Brick Kiln forthwith.
