ORDER NO. 252 JKPCC of 2024
DATED 10 -02-2024

Whereas, Consent to Operate (Renewal) was granted to **M/s Pave India , Phase-3rd**, Near **CRPF Camp, Gangyal Jammu** vide Consent No. **PCC/digital/2206274627** of 2022 dt. **19-05-2022** with validity period upto **August,2024** with some terms and conditions.

Whereas, pressing complaints against the operation of the unit have been received from LG's Grievance Cell ,which stands verified at ground as genuine.

Whereas, the owner of the unit was accordingly served with repeated notices, (latest on **22-08-2023**), calling upon him to show cause as to why legal action including closure of his unit be not taken for violation of environmental laws.

Whereas, unit holder has failed to show any response to the notices, besides failing to take measures to meet the requirements of laws governing environmental protection.

Whereas, fresh inspection of the unit was carried out by the Divisional Officer, Pollution Control Committee Jammu (South) on **04-12-2023**, revealing that unit holder was advised to erect tin barricading towards the house of the complainant, which the unit holder failed to do. Regional Director PCC Jammu vide his letter No.**PCC/RDJ/GGC-05/2024/3637-38** dt. **31-01-2024** has confirmed the report of Divisional Officer, PCC Jammu (South) and accordingly recommended it for closure.

Whereas, the unit in question cannot be allowed to operate with above status as the operation can prove detrimental for human health and environment besides being in flagrant violation of laws governing environmental protection.

Consequent upon the above, the consent to operate (Renewal) granted to **M/s Pave India , Phase-3rd**, Near **CRPF Camp, Gangyal Jammu** with validity period upto **August,2024** is hereby withdrawn with immediate effect.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under Section 33 (A) of the **Water** (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the **Air** (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, **Jammu** is directed to get the **unit** setup by **Sh. Sanjay Mahi** under the name and style of **M/s Pave India , Phase-3rd, Near CRPF Camp, Gangyal Jammu** closed immediately.
- ii. Director Industries & Commerce, **Jammu** is directed to deregister the unit, if registered.
- iii. Executive Engineer, (JKPDCL) Electric Division, Gandhi Nagar, Jammu is directed to disconnect the electric supply to **M/s Pave India , Phase-3rd, Near CRPF Camp, Gangyal Jammu** immediately.
- iv. Executive Engineer, PHE Jammu is directed to disconnect the water supply to **M/s Pave India , Phase-3rd, Near CRPF Camp, Gangyal Jammu** immediately.
- v. **Sh. Sanjay Mahi, Prop. M/s Pave India , Phase-3rd, Near CRPF Camp, Gangyal Jammu** is directed to cease the operation of the unit forthwith.
