
ORDER NO.: 258 JK PCC of 2024
DATED : 10-02-2024

Whereas, closure of **M/s Rajinder Furniture House, Ward No.60, Masjid Mohalla Near J&K Bank ATM, Paloura, Jammu** was ordered by the J&K Pollution Control Committee vide **Order No. 22 of JKPC of 2022 dt. 07-06-2022**, on the basis of complaint from nearby residents for causing noise pollution.

Whereas, fresh inspection was carried out by the Divisional Officer, Pollution Control Committee, Jammu (North) on **06-12-2023**, revealing that the withdrawal of closure order against the shop be considered *with the condition that no noise pollution shall be caused while undertaking the activity of manufacturing/repairing of furniture items in the shop that causes noise and inconvenience to the complainant and nearby residents* with photographic evidence and also reported that the closure order has been implemented by the District Administration.

Whereas, Regional Director, Pollution Control Committee, Jammu vide letter No. **PCC/RDJ/C-1018/2024/3380-81 dt. 11-01-2024** confirmed the report of the Divisional Officer, Pollution Control Committee, Jammu (North) and has accordingly recommended the withdrawal of closure order against the shop, with the condition that the shop owner shall take all necessary precautions to control the noise pollution while manufacturing the joinery items.

Now, therefore, closure order No. **22 of JKPC of 2022 dt. 07-06-2022** issued against **M/s Rajinder Furniture House, Ward No.60, Masjid Mohalla Near J&K Bank ATM, Paloura, Jammu** is hereby withdrawn with immediate effect, subject to the condition that the shop owner shall take all necessary precautions to control the noise while manufacturing the joinery items.
