Whereas, no activity having bearing on environment can be set up or put in operation, without the prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, **Slaughter House** is classified in **orange category**, for the purposes of obtaining of consent from the Committee, keeping in view the pollution potential of the Slaughter House.

Whereas, **Slaughter House** has been established and put in operation by one **Sh. Nisar Ahmad Mir at Nalband Pora Safakadal Srinagar** unauthorizedly in flagrant violation of the above stated laws that too without consent from the J&K Pollution Control Committee and operation of the slaughter House with present status can prove detrimental to human health and environment.

Whereas, the Slaughter House was accordingly served with repeated notices, particularly notice dated **18-11-2023**, calling upon him there under to show reasons as to why legal action including closure of his Slaughter House be not taken.

Whereas, the Slaughter House has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection.

Whereas, fresh inspection was carried out by the Divisional Officer, Pollution Control Committee Srinagar on 13-11-2023, revealing that the status of the Slaughter House remained unchanged. Regional Director, Pollution Control Committee Kashmir vide letter No. PCC/RoK/LS/24/03-04 dated 11-01-2024 confirmed the inspection report of Divisional Officer, PCC Srinagar and accordingly recommended it for closure.



Whereas, the Slaughter House in question cannot be allowed to run un-authorizedly with above status to the detriment of human health and environment.



Now therefore in exercise of powers vested in the J & K Pollution Control Committee under **Section 33(A)** of the **Water (Prevention & Control of Pollution) Act 1974** and **Section 31(A)** of the **Air (Prevention and Control of Pollution) Act, 1981** read with Section 5 of Environment (Protection) Act, 1986, the following directions are hereby issued:-

- i) Deputy Commissioner/ District Magistrate, **Srinagar** is directed to close down the **Slaughter House** established by **Sh. Nisar Ahmad Mir** at **Nalband Pora Safa Kadal Srinagar**, immediately.
- ii) Executive Engineer, PHE, Srinagar is directed to disconnect the water supply to the above said Slaughter House immediately.
- iii) Executive Engineer KPDCL Srinagar is directed to disconnect the electric supply to above said Slaughter House immediately.
- iv) Sh. Nisar Ahmad Mir, Prop. **Slaughter House at Nalband Pora Safakadal Srinagar** is directed to cease the operation of the Slaughter House forthwith.
