Order No. : 23 JK PCC of 2024
Dated : 04/04/2024

Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee, warranted under **Section 25/26** and **Section 21** of the **Water (Prevention and Control of Pollution) Act 1974** and **Air (Prevention and Control of Pollution) Act, 1981** respectively.

Whereas, Brick Kiln is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK Pollution Control Committee.

Whereas, Hon'ble National Green Tribunal in its order dt.**02-02-2024** in O.A.No.**594 of 2022** titled Syed Riyaz Versus Union Territory of J&K & Ors. directed to close down the brick kilns operating without consent from the Pollution Control Committee.

Whereas, the owner of the Brick kiln has applied for CTO(R) vide application No. 4383866, after thorough examination, it was found that the brick kiln falls within 10 Kms of NAC limits of Non Attainment City of Srinagar and also the brick kiln is not yet shifted to zig zag technology and accordingly Consent to Operate (Renew) was refused to the Brick Kiln vide letter No. JKPCCT/T/C/24/4383866, of 2024 dated 03-04-2024.



Whereas, Brick Kiln under the name and style of **M/s Global Brick Kiln, Seerbag Sholipora- Budgam** is operational in flagrant violation of above said requirements of law **without obtaining consent** from the J&K Pollution Control Committee so far and operation of the Brick Kiln with present status can prove detrimental to human health and environment.

Whereas, the Brick Kiln in question cannot be allowed to operate with above status as the operation can prove detrimental for human health and environment besides being in flagrant violation of laws governing environmental protection.

Now, therefore, in exercise of powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, **Budgam** is directed to close down the brick kiln under the name and style of **M/s Global Brick Kiln, Seerbag Sholipora- Budgam** immediately.
- ii. *Director Industries and Commerce, Kashmir* is directed to deregister the Brick Kiln, if registered
- iii. *Executive Engineer, (KPDCL) Electric Division, Budgam* is directed to disconnect the electric supply to above said Brick Kiln immediately.
- iv. Executive Engineer, **PHE**, Budgam is directed to disconnect the water supply to the above said Brick Kiln immediately.
- v. (Prop.) **M/s Global Brick Kiln, Seerbag Sholipora- Budgam** is directed to cease the operation of the Brick Kiln forthwith.
