Whereas, no industrial unit can be set up or run, without the prior consent of the Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, M/s Hilal Stone Crusher, Shankerpora Anantnag has failed to obtain up to date consent as such is currently in operation in flagrant violation of the above stated laws that too without adequate pollution control devices and other pollution control measures.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 31-05-2023, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.

Whereas, the unit holder has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection

Whereas, the Regional Director, JK PCC (K) vide his letter No. PCC/ROK/LS/24/32-33 dated 06-04-2024 has recommended closure of the unit.

Whereas, the unit in question cannot be allowed to run un-authorizedly with above status to the detriment of human health and environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Committee under Section 33 (A) and Section 31 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively, read with Section 5 of Environment (Protection) Act, 1986, immediate closure of M/s Hilal Stone Crusher, Shankerpora - Anantnag is hereby ordered and in this behalf the:-

- Deputy Commissioner/ District Magistrate, Anantnag is directed to get M/s Hilal Stone i). CrusherArhama Anantnag, closed immediately.
- Exe. Engineer, Electric & Maintenance (KPDCL) Anantnag is directed to disconnect the ii). electric supply to the above said unit immediately.
- Director, Industries & Commerce Department, Kashmir is directed to deregister the iii). units.
- Prop. M/s Hilal Stone Crusher, Shankerpora Anantnag is directed to cease the iv). operation of the unit forthwith.
