Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, **Dairy Farm** is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK PCC.

Whereas, M/s Milky Way Dairy Farm, near Bagh-E-Zeeenab,Bunhama, Pantha Chowk, Srinagar has been set up and put in operation in violation of above stated laws that too bereft of adequate pollution control devices/ measures.

Whereas, pressing complaints against operation of the units have also been received and it has been found that the Dairy Farm is causing pollution in the area which is detrimental to the public health and is in operation in flagrant violation of the environmental norms and the laws existing thereto

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 13-01-2024, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken for setting up the dairy farm without consent of the JKPCC, that too at objectionable site.

Whereas, the unit holder has failed to give any tenable reason for setting up the unit in residential area without permission/ consent of the JK PCC.

Whereas, Regional Director, JK PCC Kashmir vide his No. PCC/ROK/LS/24/34-35 dated 29-04-2024 has forwarded his recommendations for issuing closure against the dairy unit.

Whereas, the unit in question cannot be allowed to run un-authorizedly with above status and to the determent of human health and environment.

Now therefore in exercise of powers vested in the J & K Pollution Control Committee under Section 33(A) of the Water (Prevention & Control of Pollution) Act 1974 Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of **M/s Milky Way Dairy Farm,** near Bagh-E-Zeeenab,Bunhama, Pantha Chowk, Srinagar is hereby ordered and in this behalf the:-

- Deputy Commissioner/ District Magistrate, Srinagar is directed to get M/s Milky Way Dairy Farm, near Bagh-E-Zeeenab, Bunhama, Pantha Chowk, Srinagar closed immediately.
- ii). Exe. Engineer, Electric & Maintenance (PDD) **Panthachowk-Srinagar** is directed to snap the electric supply to the above said unit immediately.
- iii). Director Animal Husbandry, Kashmir for deregistering the unit.
- iv). Prop M/s Milky Way Dairy Farm, near Bagh-E-Zeeenab, Bunhama, Pantha Chowk, Srinagar is directed to cease the operation of the unit forthwith.
