Whereas, Consent to Establish (F) was granted to M/s K.S. Constructions (JV), Sumber-Ramban vide Consent Order No. PCC/digital/23012135700 of 2023 dated 23-03-2023 valid upon March, 2024, thereafter unit holder has not applied/renewed the consent from the Pollution Control Committee as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, stone crusher is classified in **Orange** category on the basis of its pollution potential, for the purposes of obtaining consent from the Pollution Control Committee.

Whereas, Mr. Murli Choudhary has set up and put in operation stone crusher under the name and style of M/s K.S. Constructions (JV), Sumber-Ramban in flagrant violation of the above stated law without obtaining consent from the JK Pollution Control Committee.

Whereas, the owner of the unit was accordingly served with notices, (latest on **09-11-2023**), calling upon him to show cause as to why legal action including closure of his unit be not taken for violation of environmental laws.

Whereas, the owner of the unit has failed to respond to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection.

Whereas, fresh inspection of the unit was carried out by the Divisional Officer, Pollution Control Committee Ramban on 12-03-2024, revealing that the unit has not installed the PCDs/PCMs viz, proper covering ,inadequate water sprinkling system and is operational without Consent from the JKPCC. Regional Director, Pollution Control Committee Jammu vide letter No. PCC / RDJ / 2024/39-40 dt. 03-04-2024 confirmed the inspection report of the Divisional Officer, PCC Ramban and accordingly recommended for closure of the unit.

Whereas, the unit in question cannot be allowed to operate with above status as the operation can prove detrimental for human health and environment besides being in flagrant violation of laws governing environmental protection.

Now therefore in exercise of powers vested in the J & K State Pollution Control of Pollution) Act Now therefore in exercise of powers and Control of Pollution) Act, 1981
