Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee, warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively and;

Whereas, Poultry Farm is categorized as **Green Category** activity on the basis of pollution potential, for the purposes of seeking the consent from the Board/Committee and;

Whereas, **M/s Dar Poultry Farm at Growgund Kulpora-Pulwama** has been set up and put in operation at objectionable site, in violation of above stated laws that too bereft of adequate pollution control devices/ measures and;


Whereas, complaints against the said Poultry Farm have been received through LGs Grievance Cell vide **Compt. No. 999004963425**, which stand verified as genuine and the Regional Director, JK PCC (K) vide his letter No. **PCC/ROK/LS/24/Co/47-48 dated 07-05-2024** have recommended for closure of the said poultry farm and;

Whereas, the poultry farm in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now therefore, in exercise of powers vested in the J & K Pollution Control Committee under **Section 31 (A)** of the **Air (Prevention and Control of Pollution) Act, 1981**, read with **Section 5** of Environment **(Protection) Act, 1986**, immediate closure of **M/s Dar Poultry Farm at Growgund Kulpora-Pulwama** is hereby ordered:-

- i). Deputy Commissioner/ District Magistrate, Pulwama is directed to get the poultry farm under the name and style of M/s Dar Poultry Farm at Growgund Kulpora-Pulwama closed immediately.
- ii) Director Animal Husbandry, Kashmir for deregistering the unit, if registered.
- iii). Executive Engineer, KPDCL, Pulwama is directed to snap the electric supply to the above said unit immediately.
- iv). Prop M/s Dar Poultry Farm at Growgund Kulpora-Pulwama is directed to cease the operation of the unit forthwith.
