Whereas, stone crusher is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK Pollution Control Committee, and,

Whereas, Consent to Operate (Renewal) was granted to **M/s Motel Stone Crusher, Kheri Dandyal Jagti Nagrota, Jammu North, District Jammu** vide No. **PCC/digital/23063462966 dated 10-03-2023** with specific condition that the unit holder will submit the requisite documents from the Revenue Department as per Rule 10 of S.O. 60 of 2021 dt. 23-02-2021 within a period of three months from the issuance of CTO(R), and,

Whereas, under Rule 10 of Jammu and Kashmir Stone Crushers/Hot and Wet Mixing Plants Regulation Rules, 2021 issued vide SO 60 of 2021 dated 23-02-2021, No Objection Certificate from Deputy Commissioner concerned regarding title verification of land and its usage is a pre-requisite as one time requirement for renewal of Consent to Operate, and,


Whereas, **M/s Motel Stone Crusher, Kheri Dandyal Jagti Nagrota, Jammu North, District Jammu** has again applied for grant of Consent to Operate (R) vide application No. **4342625** under section 25/26 of **Water (Prevention and Control of Pollution) Act, 1974** and **Section 21** of the **Air (Prevention and Control of Pollution) Act, 1981**, which has been refused vide letter No. **JKPCC/T/C/24/4342625 of 2024 dated 07-05-2024** "on the ground that neither unit holder has submitted the NOC from the concerned Deputy Commissioner as required under S.O.60 of 2021 dt. 23-02-2021 nor he has submitted copy of the license issued by the Mining Department under the provisions of J&K Minor Minerals Exploitation and Processing Rule,2017, and,

Whereas, **M/s Motel Stone Crusher, Kheri Dandyal Jagti Nagrota, Jammu North, District Jammu**, cannot be permitted to operate without consent from the J&K Pollution Control Committee, in view of the above facts and position explained above.

Now therefore in exercise of powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued: -

- i. Deputy Commissioner/ District Magistrate, **Jammu** is directed to close down the stone crusher under the name and style of M/s **Motel Stone Crusher, Kheri Dandyal Jagti Nagrota, Jammu North, District Jammu** immediately.
- ii. Director Industries and Commerce, **Jammu** is directed to de-register the stone crusher, if registered.
- iii. Executive Engineer, (JPDCCL) Electric Division, **Jammu** is directed to disconnect the electric supply to above said stone crusher immediately.
- iv. Executive Engineer, **PHE**, **Jammu** is directed to disconnect the water supply to the above said stone crusher immediately.
- v. **Prop. M/s Motel Stone Crusher, Kheri Dandyal Jagti Nagrota, Jammu North, District Jammu** is directed to cease the operation of the stone crusher, forthwith.
