Closure of M/s Ajeet Sharma Contractor (Stone Crusher), Village Nambal, Tehsil & District Reasi

> Order No. : 139 JK PCC of 2024 Dated : 27/07/2024

Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee, warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively and;

Whereas, stone crusher is categorized as **Orange Category** activity on the basis of pollution potential, for the purpose of seeking the consent from the JK Pollution Control Committee and;

Whereas, M/s Ajeet Sharma Contractor (Stone Crusher), Village Nambal, Tehsil & District Reasi is in operation in flagrant violation of the Section 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 without obtaining consent from the J&K Pollution Control Committee and operation of the stone Crusher in its present status can prove detrimental to human health and environment and;

Whereas, notices were served upon the owner of the stone crusher, on 03-05-2024 and 30-05-2024 calling upon him to show cause within 15 days as to why legal action including closure of his stone crusher be not taken for violation of various environmental laws and;

Whereas, fresh inspection was conducted by the Divisional Officer, Pollution Control Committee Reasi on 07-06-2024, reporting that the owner of the stone crusher has never obtained consent from the J&K Pollution Control Committee and operating the stone crusher without Emission Control Devices (ECD) and;

Whereas, Regional Director, Pollution Control Committee, Jammu vide letter No. PCC/RDJ/O/24/757-59 dated 11-06-2024 confirmed the inspection report of Divisional Officer, PCC Reasi and accordingly recommended for closure and;

Whereas, the stone crusher in question cannot be allowed to operate with above status as the operation can prove detrimental for human health and environment besides being in flagrant violation of laws governing environmental protection.

Now therefore in exercise of powers vested with J & K Pollution Control Board under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- Deputy Commissioner/ District Magistrate, Reasi is directed to close down the stone crusher under the name and style of M/s Sharma Stone Crusher, Village Ranjan Jingyani Garota -District Jammu immediately.
- ii. Director Industries and Commerce, Jammu is directed to deregister the stone crusher, if registered.
- iii. Executive Engineer, (JPDCL) Electric Division, Reasi is directed to disconnect the electric supply to above said stone crusher.
- iv. Executive Engineer, PHE, Reasi is directed to disconnect the water supply to the above said stone crusher.
- v. *Prop. M/s Ajeet* Sharma Contractor (Stone Crusher), Village at Village Nambal, Tehsil & District Reasi is directed to cease the operation of the stone crusher, forthwith.
